Third Lease Amendment for Office Space at 550 Quarry Road, San

Carlos, California for the Human Services Agency. (Lease No. 1146)

### Recommendation

Adopt a Resolution authorizing the President of the Board of Supervisors to execute a Third Lease Amendment with Vernazza Properties for office and warehouse space at 550 Quarry Road, San Carlos, California.

#### **Background**

The Human Services Agency occupies office and warehouse space in the building at 550 Quarry Road under the terms of the lease dated December 15, 1998, as amended by the First Amendment and as amended by the Second Amendment. The proposed Third Lease Amendment to the 550 Quarry Road lease provides for the lease of an additional 3,000 rentable square feet of office and warehouse space on the first floor which will be used by HSA to alleviate overcrowding in adjacent areas of the building.

#### Discussion

A Third Lease Amendment has been negotiated with Vernazza Properties. Under the terms of the Amendment the County will pay \$1.04 per square foot per month for a total monthly increase of \$3,120. The rate was established under the terms of the original lease. As a result of this Amendment, the County will occupy the entire 70,104 square foot building at a total monthly rent of \$82,681.30 (\$1.18 per square foot). This total includes \$7,033.18 for the amortization of the cost of improvements made to the building on behalf of the County in 1999.

The Director of the Human Services Agency concurs in this recommendation. County Counsel has reviewed and approved the Third Lease Amendment as to form.
