SAN MATEO/BAY AREA BIOSCIENCE CAREER (ABC) PROJECT

In your letter to Mr. Ron Addy dated December 18, 2003, you requested the Employment Development Department's (EDD) permission to assign all rights and responsibilities for one of your subcontractors on the Bay ABC project to another subcontractor. Your agreement with EDD as documented in our Workforce Investment Act (WIA) subgrant does not specify which subcontractors you should employ to meet your responsibilities for this project.
