WHEREAS, on this sixteenth day of July, 2004, MICHAEL S. LOPEZ is honored for more than thirty-three years of dedicated service to San Mateo County Law Enforcement; and

WHEREAS, MICHAEL S. LOPEZ began his long and distinguished career in 1971 as a Reserve Deputy Sheriff with the San Mateo County Sheriff's Office; and

WHEREAS, in 1972, MICHAEL S. LOPEZ went on to serve as a reserve police officer for the City of Millbrae where he became a police officer in 1973 and was assigned to numerous duties including patrolman, investigator and motorcycle officer; and

WHEREAS, MICHAEL S. LOPEZ received an Associate Degree in Administration of Justice from the College of San Mateo in 1977 and continued his education at the College of Notre Dame, National University and Golden Gate University; and

WHEREAS, in 1980, MICHAEL S. LOPEZ became a Deputy Sheriff with the San Mateo County Sheriff's Office until he was promoted to Sheriff's Sergeant in 1984; and

WHEREAS, in 1987, MICHAEL S. LOPEZ received the Trustee Leadership Award for outstanding service to the community; and

WHEREAS, MICHAEL S. LOPEZ was promoted to Lieutenant in 1988 and has served in that capacity for the past 16 years with assignments in the Sheriff's Classification Unit, County Hospital Detention Commander, Main Jail Commander, Men's Correction Center Commander, Maguire Correctional Facility Watch Commander and Detective Bureau Commander; and


WHEREAS, in 1990, MICHAEL S. LOPEZ was appointed as special project coordinator of the Electronic Home Detention Monitoring Program, and instituted the first Drug and Alcohol Program for inmates in the Maguire Correctional Facility in 1991, and served on the Board of Directors of the San Mateo County Service League from 1990 to 2001,



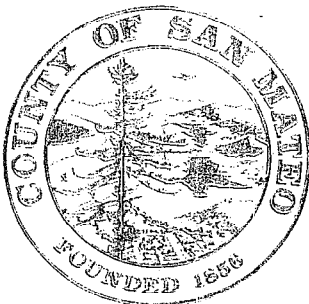


