NANCY KRAUS

WHEREAS, on this twenty-first day of August, 2004, NANCY KRAUS is honored for her more than twenty-one years of service for the San Mateo Union High School District; and

WHEREAS, NANCY KRAUS began working for the District as community liaison and as assistant to Principal Gordon Young and then Principal Samuel Johnson, Jr. at Capuchino High School; and

WHEREAS, during her tenure at Capuchino High School, NANCY KRAUS was instrumental in providing opportunities for the school to actively engage parents and the community through numerous functions including the Open House and designing and writing the first parent newspaper and a weekly, local newspaper column; and

WHEREAS, NANCY KRAUS established herself early on as a proven leader, effective problem solver and dedicated professional who was highly respected by faculty, parents and the student body which awarded her with Martin Luther King Award for Outstanding Leadership from the school's Black Student Union and the Woman of the Year Award from the Student Government; and

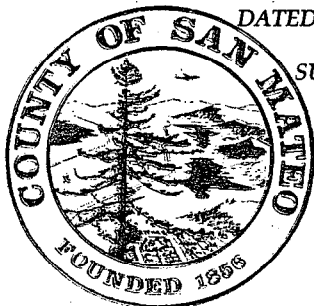
WHEREAS, NANCY KRAUS left Capuchino High School and went to the District Office where she began working for Tom Mohr when he was Associate Superintendent and then Superintendent until his retirement when his successor and her old boss, Samuel Johnson, Jr., took the helm as Superintendent; and

WHEREAS, NANCY KRAUS continued her community outreach efforts for the District by developing and coordinating numerous public meetings and forums for the Superintendent to interact with the community; coordinating a council of parent leaders from all district schools to collaborate amongst themselves and with district leaders; and designing and implementing a word processing department to more effectively disseminate all facets of internal and external communication; and

WHEREAS, one of the greatest accomplishments of NANCY KRAUS was her tireless commitment and unwavering determination on the campaign to pass the District's school bond which provided \$137.5 million for refurbishing the six high schools,

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of San Mateo County expresses congratulations and sincere gratitude to NANCY KRAUS for more than twenty-one years of distinguished service to the San Mateo Union High School District. Her proven leadership, brilliant problem solving skills, enthusiastic dedication, and extraordinary commitment to teachers, administrators, parents, and students have served the community well and raised the bar of excellence in the District's high quality of service in education.
