A LIFE AND ANNUITY CONSUMER PROTECTION FUND**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of
California, that

WHEREAS, Assemblymember Wilma Chan has introduced AB 2316, which would
create the Life and Annuity Consumer Protection Fund to protect consumers from life insurance
and annuity fraud; and

WHEREAS, resources from this fund could be used to reduce cases of such fraud in
San Mateo County; and

WHEREAS, the San Mateo County Commission on Aging supports AB 2316 in an
effort to reduce life insurance and annuity product financial abuse; and

WHEREAS, support of AB 2316 (Chan) furthers the County's Vision 2010
commitment to ensure basic health and safety for all and supports Goal #8 to help vulnerable
people including those who are elderly or have disabilities and others achieve a better quality of
life;

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the
San Mateo County Board of Supervisors by the adoption of this resolution hereby
supports AB 2316 and requests the Governor's signature.

**RESOLUTION IN SUPPORT OF ACR 154 (MATTHEWS)
REGARDING ESTABLISHING MAY AS
“ELDER AND DEPENDANT ADULT ABUSE AWARENESS MONTH”**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Assemblymember Barbara Matthews has introduced ACR 154, which would permanently establish May as “Elder and Dependent Adult Abuse Awareness Month”; and

WHEREAS, San Mateo County like other communities throughout California are concerned about elder and dependant adult abuse; and

WHEREAS, the San Mateo County Commission on Aging supports ACR 154 to assure increased awareness regarding elder and dependent adult abuse throughout the State; and

WHEREAS, support of ACR 154 (Matthews) furthers the County’s Vision 2010 commitment to ensure basic health and safety for all and supports Goal #8 to help vulnerable people including those who are elderly or have disabilities and others achieve a better quality of life;

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the San Mateo County Board of Supervisors by the adoption of this resolution hereby supports ACR 154 and urges reintroduction of such legislation should ACR 154 not pass the Legislature during the 2003-2004 Legislative Session.

**RESOLUTION IN SUPPORT OF H.R. 4585 (HOYER),
FULL-SERVICE COMMUNITY SCHOOLS ACT OF 2004**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Congressman Steny Hoyer has introduced H.R. 4585, which would authorize funding for full-service community schools, which are public elementary or secondary schools that coordinate multiple federal, state and/or local educational and social service programs through community-based organizations and public/private partnership; and

WHEREAS, the use of full-service community schools best utilize resources, which results in more cost-efficient services; and

WHEREAS, San Mateo County's Family Resource Centers provide a variety of prevention and early intervention social services through partnerships between schools and nonprofits throughout the County; and

WHEREAS, the Family Resource Centers could benefit from the full-service community school funding; and

WHEREAS, support of H.R. 4585 would further the County's Vision 2010 commitment to ensure basic health and safety for all and would support Goals #5, 6 and 8 that residents, including children, have access to healthcare and safe neighborhoods and that vulnerable people achieve a better quality of life;

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the San Mateo County Board of Supervisors by the adoption of this resolution hereby supports H.R. 4585 and urges the San Mateo County Congressional Delegation to co-sponsor the bill.
