1. CORONADO AVENUE (#1490) was added to County Road System by Board of Supervisors Resolution No. 066533 adopted on March 2, 2004. Added 0.26 miles to the County Maintained Road System

1. MARION DRIVE (#677) was annexed to the Town of Woodside by Resolution No. 945 passed and adopted on January 15, 2003. Delete 0.04 miles from County Maintained Road System.
2. WARD WAY (#678) was annexed to the Town of Woodside by Resolution No. 945 passed and adopted on January 15, 2003. Delete 0.19 miles from County Maintained Road System.
3. GREENWAYS DRIVE (#695) was annexed to the Town of Woodside by Resolution No. 945 passed and adopted on January 15, 2003. Delete 0.21 miles from County Maintained Road System.

Road Name Changes (No Change to Total Maintained Mileage)

1. TOWER ROAD (#17-C) formerly POLHEMUS ROAD (#17-C), was officially changed FROM Polhemus Road TO Tower Road by San Mateo County Zoning Hearing file #PLN 2004-00135 dated May 20, 2004. The portion of the road branching southerly from County Road #324 to the Construction Services Facilities; length 0.20 miles.
2. PAUL SCANNELL DRIVE (#324) formerly a portion of TOWER ROAD (#324) was officially changed FROM Tower Road TO Paul Scannell Drive by San Mateo County Zoning Hearing file #PLN 2004-00135 dated May 20, 2004. The portion of road running generally east to west from County Road #19 Ralston Avenue; length 0.40 miles.
3. LESSINGIA COURT (#1491) formerly a portion of TOWER ROAD (#324) was officially changed FROM Tower Road TO Lessingia Court by San Mateo County Zoning Hearing File #PLN 2004-00135 dated May 20, 2004. The portion of road branching southerly from County Road #324 to the existing main library building; length 0.20 miles.
