

**FIRST AMENDMENT TO AGREEMENT

**WHEREAS**, the parties wish to amend the Agreement to extend the term to January 31, 2006 and replace the time schedule to reflect the new term

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

The term of this Agreement shall be from February 4, 2003 to January 31, 2006.

3. All other terms and conditions of the Agreement dated February 4, 2003 shall remain the same and in full force and effect.


