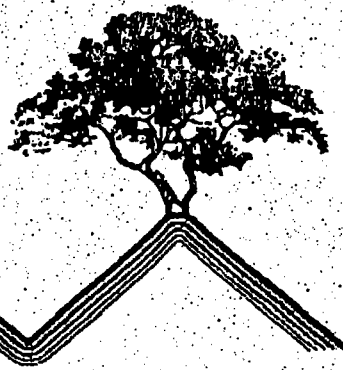

If confirmed, he looks forward to participating as a member of the Ladera Recreation District Board of Directors, and helping preserve this unique and valuable community asset.


We trust that Richard Hamner's qualifications meet with approval from the County Board of Supervisors and we look forward to hearing from you.
