

**AMENDMENT TO THE AGREEMENT FOR SERVICE BETWEEN
The County of San Mateo
AND
Youth and Family Enrichment Services for the
Sequoia Teen Resource Center**

THIS AMENDMENT TO AGREEMENT, is entered into this _____ day of _____, 2005, by and between Youth and Family Enrichment Services for the Sequoia Teen Resource Center (YFESSTRC) and the County of San Mateo (CONTRACTOR).

WHEREAS, the YFESSTRC desires counseling and child abuse prevention services for families living in the area serviced by YFESSTRC; and

WHEREAS, the CONTRACTOR desires to provide counseling and child abuse prevention services for families living in the area services by YFESSTRC; and

WHEREAS, it is necessary and desirable that the Parties enter an Amendment to the Agreement to extend the term of the Agreement from July 1, 2004 trough June 30, 2006 to July 1, 2004 through June 30, 2007 and to add funds for the Fiscal Years 2005-2006 and 2006-2007 in the aggregate amount of \$66,100 for the total amount of \$110,100 and.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND CONDITIONS CONTAINED HEREIN, THE PARTIES AGREE AS FOLLOWS:

1. Subsection B of Paragraph 1 titled “**SERVICES**” shall be deleted and replaced in its entirety with the following:

B. Youth and Family Enrichment Services Sequoia Teen Resource Center (YFESSTRC) will:

- Reimburse Contractor up to a maximum of \$44,000 for the cost of one half the Salaries and Benefits for one full time Psychiatric Social Worker outposted at YFESSTRC for Fiscal Year 2004-2005; and
- Reimburse Contractor up to a maximum of \$66,100 for the partial cost of Salaries and Benefits for one full time Psychiatric Social Worker outposted at YFESSTRC for Fiscal Years 2005-2006 and 2006-2007 as set forth in Paragraph 9 below.

2. Paragraph 2 titled “**AMOUNT OF SERVICES**” shall be deleted and replaced in its entirety with the following:

The CONTRACTOR agrees to provide 1 FTE Psychiatric Social Worker for the Fiscal Years 2004-07.

3. Paragraph 3 titled “**TERM OF AGREEMENT**” shall be deleted and replaced in its entirety with the following:

The Agreement shall be binding on the Parties upon execution of this Agreement by all Parties. The Agreement, effective July 1, 2004, shall continue in effect through June 30, 2007.

4. Paragraph 9 titled “**COMPENSATION**” shall be deleted and replaced in its entirety with the following:

The **CONTRACTOR** agrees to perform all of the services of the Agreement for a total not to exceed \$35,800 for the Fiscal Year 2005-06 and \$30,300 for the Fiscal Year 2006-07.

5. All other terms and conditions of the Agreement dated July 1, 2004, between YFESSTRC and Contractor shall remain in full force and effect.

6. This Amendment constitutes the entire understanding of the parties hereto with respect to the amendment to the parties’ Agreement dated July 1, 2004 and correctly states the rights, duties, and obligations of each party as of this document's date. Any prior understandings, promises, negotiations, or representations between the parties not expressly stated in this document are not binding. All subsequent modifications shall be in writing and signed by the parties.
