SUBJECT: Correction of Property Tax Roll, APN 039-381-110

RECOMMENDATION:

Approve a correction to the 2005 property tax rolls to correct for welfare exemption related to APN 039-381-110, located at 2701 Flores Street, San Mateo (the "Property").

VISION ALIGNMENT:

Commitment: responsive, effective, and collaborative government.

Goal 20: Government decisions are based on careful consideration of future impact, rather than temporary relief or immediate gain.

The implementation of this recommendation will further commitments and assist in achieving goals set forth in the County's <u>Shared Vision 2010</u> report. Specifically, this proposal implements the commitment of providing "responsive, effective and collaborative government."

BACKGROUND:

San Mateo Rotary Floritas L.P. purchased the Property on October 30, 2003 and has constructed a 50 unit apartment building to be used as low-income housing. In August 2004, Mid-Peninsula Housing Coalition, the non-profit limited partner of

Rotary Floritas LP, and Rotary Haciendas Inc., the non-profit general partner of Rotary Floritas LP, applied for the welfare exemption pursuant to section 214 of the Revenue and Taxation Code.

DISCUSSION:

After review of the welfare claim, the Assessor has found that all requirements have been met and approval of the roll corrections completed for the 2005/2006 roll is requested. The calculations and tax bill display are attached for reference.

FISCAL IMPACT:

The fiscal impact of this action is a \$50,419.10 decrease in the 2005 roll. The County's General Fund share of that decrease is approximately 14% of the decrease (i.e., approximately \$7,058.67).
