THIRD AMENDMENT TO THE AGREEMENT BETWEEN COUNTY OF SAN MATEO AND HAGMAN ASSOCIATES ARCHITECTS FOR ARCHITECTURAL SERVICES IN THE REHABILITATION OF THE SAFE HARBOR SHELTER

THIS THIRD	AMENDMENT TO THE AGREEMENT entered into this
day of	, 2006, by and between the County of San Mateo
("County") and Hagman	Associates Architects ("Contractor").

WITNESSETH

WHEREAS, under Agreement # 067034, the County and the Contractor entered into an Agreement to provide \$135,000 in CDBG funds for architectural services in the rehabilitation of the Safe Harbor Shelter located at 295 North Access Road in South San Francisco; and

WHEREAS, \$42,000 was added to the Original Agreement under the First Amendment under Agreement # 067267 to accommodate increased costs of architectural services due to additional requirements presented by the South San Francisco Fire Department and to add an internal lift (the "First Amendment"); and

WHEREAS, an additional \$50,000 was added under the Second Amendment under Agreement # 067603 for the purpose of design and construction services to satisfy additional requirements set forth by the South San Francisco Fire Department and to abate accessibility issues (the "Second Amendment"); and

WHEREAS, all parties now wish to add the amount of \$175,000 under this Third Amendment for a new total of \$402,000 to accommodate hard (modular units, cots, temporary fencing) and soft (architecture fees, portable restroom servicing, inspections) costs as the Safe Harbor Shelter Rehabilitation Project enters the Construction Phase; and

WHEREAS, it is now the mutual desire and the intent of the parties hereto to further amend and clarify the Original Agreement as modified by the First and Second Amendments.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO THAT THE ORIGINAL AGREEMENT, AS AMENDED BY THE FIRST AND SECOND AMENDMENTS IS FURTHER AMENDED AS FOLLOWS:

Total Contract Obligation Amount shall now be \$402,000. The attached Exhibit A and Exhibit B replace the existing Exhibit A and Exhibit B.

All other terms and conditions of the Original Agreement as modified by the First, Second and Third Amendments shall remain in full force and effect.

IN WITNESS, WHEREOF, the parties hereto, by their duly authorized representatives, have affixed their hand to this Third Amendment.

Exhibit A Program/Project Description

In consideration of the payments set forth in Exhibit "B", Contractor shall provide the following services:

Design development, including interior finishes selections, creation of necessary construction documents, creation of work specifications, help to coordinate the project bidding process, handling and overseeing the required permits including adherence to code issues, administration in cooperation with Department of Housing staff on the overall construction project in addition to ongoing communication and meetings with Department of Housing staff, contractors and all other parties involved.

Contractor will be responsible for the overall construction development and engineering requirements in the rehabilitation project of the Safe Harbor Shelter, located at 295 North Access Road in South San Francisco.

All work shall be in accordance with governing codes, local ordinances and accessibility requirements.

The following work shall be performed in addition to the scope of work described in the Original Agreement and the First and Second Amendments:

Procurement including rental and set up of modular units.

Oversight of cot procurement.

Oversight of power and data connection and disconnect.

Procurement including installation of temporary fencing and water hook-up.

Move coordination including moving costs.

Oversight of portable restroom servicing.

Additional architectural and inspection services.

Exhibit B Method and Rate of Payment

In consideration of the services provided by Contractor in Exhibit "A", County shall pay Contractor based on the following fee schedule:

Payment to the Contractor shall be made on a time and material basis according to the estimate submitted by the Architect, approved by County and outlined on the table below; **COMPENSATION AND SCHEDULE OF HOURLY AND REIMBURSABLES BILLING FOR SAFE HARBOR SHELTER ARCHITECTURAL SERVICES.** The services to be provided include but are not limited to: creation of all preliminary and final designs, engineering services, creation of necessary design documents, facilitation of inspections, development of bidding documents, facilitation of contractors, provision of specifications and plans as required, attendance at meetings as required, and other related duties in the course of providing services as described. The maximum amount payable under this Agreement shall not exceed \$402,000.

Final invoice will be paid following final building permit sign-off. The County, under the Director of the Department of the Housing, reserves the right to be the final authority for payment and for determining the completion of all items specified under this Agreement.
