#### **RECOMMENDATION:**

Approve a correction to the 2005 regular property tax rolls to correct for the decline in value related to APN 054-320-450, located at 400 Saginaw Drive, Redwood City (the "Property").

#### **VISION ALIGNMENT:**

Commitment: responsive, effective, and collaborative government.

Goal 20: Government decisions are based on careful consideration of future

impact, rather than temporary relief or immediate gain.

The implementation of this recommendation will further commitments and assist in achieving goals set forth in the County's <u>Shared Vision 2010</u> report. Specifically, this proposal implements the commitment of providing "responsive, effective and collaborative government."

## **BACKGROUND:**

The Property is one of a group of 16 parcels under single ownership that suffered a decline in value pursuant to section 51(a)(2) of the Revenue and Taxation Code. The 16 parcels went from a total original assessed value of \$123,044,833, to \$83,000,000. The decline in value was confirmed by a mid-year sale of all 16

parcels for \$83,000,000. The decline in value for this Property results in a decrease in the 2005 tax roll of \$53,849.92. Of the 16 parcels, only this Property and one other parcel had declines in value that resulted in tax roll decreases in excess of \$50,000.

# **DISCUSSION:**

Pursuant to section 4831, *et seq.*, of the Revenue and Taxation Code, which allows for corrections to the tax roll, the Assessor proposes to correct the assessment made against the Property. The Request for Approval of Decrease of Taxes No. 05-1186 is attached for reference.

### **FISCAL IMPACT:**

There is no fiscal impact of this action. The taxpayer made no payment and no refund is due.
