# **RECOMMENDATION:**

Adopt a Resolution authorizing the President of the Board to execute an agreement with KMD Architects and Planners for architectural services in the amount of \$278,300 for the design and construction administration of a new Receiving Home to be located on the County's property on Tower Road.

## **VISION ALIGNMENT:**

**Commitment:** Ensure basic health and safety for all.

#### **BACKGROUND:**

The Board of Supervisors has approved the construction of the new San Mateo County Youth Services Center. A component of the project is the Receiving Home,

which is operated by the Human Services Agency. The new Receiving Home will replace the current facility, which was built in 1952 in San Mateo at Hacienda and 37<sup>th</sup> Avenue.

The Receiving Home originally was to be constructed with modular building units under the Turner Construction Company agreement that includes the entire Youth Services Center project. It has now been determined that conventional construction methods are more appropriate for this project. Subsequently, a request for proposal was solicited for an architect to prepare contract documents for public bidding.

## DISCUSSION:

The County advertised for proposals in November and December 2005, including outreach to local architectural firms. Five proposals were received (see Attachment A matrix). KMD Architects and Planners was determined to best meet County criteria. The services to be provided include verification of the program and preliminary schematic design as envisioned by the Receiving Home and HSA administration, design development, construction documents, LEED certification to comply with the County's Sustainable Building policy, assistance in bidding, construction administration, and project closeout.

The Receiving Home design and construction will be overseen by the Building Project Management Section of the Department of Public Works. Project completion is estimated to be October 2007.

The agreement signed by KMD Architects and Planners is presented to the Board for approval. All exhibits to the agreement are available for review at the Capital Projects Division.

#### **FISCAL IMPACT:**

The total negotiated professional consulting fee shall be \$278,300. The estimated construction cost limit shall be \$2,400,000. This component of the project is funded by the sale of lease revenue bonds.
