

**AMENDMENT TO THE REVENUE AGREEMENT FOR SERVICE BETWEEN  
Redwood City School District and The County of San Mateo**

This Amendment to the Agreement is made on this \_\_\_\_\_ day \_\_\_\_\_ 2006 by and between the Redwood City Elementary School District (RCSD) and the County of San Mateo (CONTRACTOR).

WHEREAS, the parties entered into an Agreement on February 28, 2006, whereby the County agreed to provide Social Workers at school sites in exchange for payment from RCSD, who serves as fiscal agent for the Redwood City Family Centers; and

WHEREAS, the Agreement provided that the parties would negotiate the level of service and rate of payment for the FYs 2006-2007 and 2007-2008 in the form of amendments; and

WHEREAS, the parties wish to enter into this amendment to add funding for Fiscal Year 2006-07; and

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

**1. SECTION 1 - SERVICES is amended and restated in its entirety as follows:**

The CONTRACTOR agrees to provide six Psychiatric Social Workers to RCSD for their Family Resource Centers, in accordance with the terms and conditions of this Agreement. Such Psychiatric Social Workers will remain employees of the Contractor and for administrative supervision they will report to the Southern Region Manager in Redwood City. Contractor will be partially reimbursed for the salary and benefits of the Psychiatric Social Worker out posted at Hoover Preschool in the amount of \$100,821 for the fiscal year 2005-06, and in the amount of \$100,118 for the fiscal year 2006-07. RCSD intends to pay for the salary and benefits of the Psychiatric Social Worker out posted at Hoover and Fair Oaks Preschool in the fiscal year 2007-08 and agrees that the terms of such payments will be set forth in amendment to this Agreement.

**2. SECTION 8 - COMPENSATION is amended and restated in its entirety as follows**

The CONTRACTOR agrees to assign one PSW at RCSD's Hoover School for the purposes of providing counseling and kindergarten readiness services to children and their families attending the Redwood City Family Resource Centers. Contractor will be reimbursed for an amount not to exceed \$100,821 for one Psychiatric Social Worker for the fiscal year 2005-06, and an amount not to exceed \$100,118 for one Psychiatric Social Worker for the fiscal year 2006-07. RCSD intends to pay for the salary and benefits of the Psychiatric Social Worker out posted at Hoover and Fair Oaks Preschool in the fiscal year 2007-08 and agrees that the terms of such payments will be set forth in amendment to this Agreement.

3. All other terms and conditions of the parties' original agreement dated February 28, 2006 shall remain in full force and effect. This Amendment constitutes the entire understanding of the parties hereto with respect to the amendment to the parties' Agreement and correctly states the rights, duties, and obligations of each party as of this document's date. Any understandings, promises, negotiations, or representations between the parties not expressly stated in this document are not binding. All subsequent modifications shall not be effective unless set forth in a writing executed by both parties.
