## AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, ON BEHALF OF THE SAN FRANCISCO GENERAL HOSPITAL CLINICAL PRACTICE GROUP

## WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department/Agency thereof; and

Whereas, it is necessary and desirable that Contractor be retained for the purpose of performing the professional services for the Health Department, Emergency Medical Services; and

Whereas, the parties entered into an Agreement on April 12, 2005; and Whereas, the parties wish to amend the Agreement, Exhibit B. A. Payments to an hourly pay rate for hours worked.

Now, therefore, it is hereby agreed by the parties hereto as follows:

Exhibit B A. is amended to read as follows:

A. Effective September 1, 2006, Contractor shall be paid for work performed at a rate of ONE HUNDRED THIRTY THREE DOLLARS (\$133.00) per hour. Contractor will submit a summary of work performed monthly and the number of hours worked which will be submitted with invoices.

All other terms and conditions of the agreement dated April 12, 2005, between the County and Contractor shall remain in full force and effect.
