**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the California Office of Emergency Services (OES) administers grant funding to counties for the California Multi-Jurisdictional Methamphetamine Enforcement Team (Cal-MMET), which supports a regional approach to reduction in methamphetamine production and distribution, reduction in availability of methamphetamine on the street, and reduction in methamphetamine related criminal offenses; and

**WHEREAS**, the County of San Mateo has applied for \$330,000 in Cal-MMET funds, and has indicated that the Sheriff will manage the Cal-MMET Grant, and that the funds will be allocated to the San Mateo County Narcotics Task Force to support a regional approach to interdict the flow of methamphetamine throughout the County; and

**WHEREAS**, implementation of the Cal-MMET grant will require an agreement between the County of San Mateo and OES, and the commitment of the Board of

Directors of the San Mateo County Narcotics Task Force to comply with all terms and conditions of the Cal-MMET program; and

**WHEREAS**, the Board of Directors of the San Mateo County Narcotics Task Force has confirmed its intent to comply with all grant terms and conditions, and in order to ensure a timely implementation the FY 2006/2007 grant funds, has requested this Board to authorize Sheriff to sign the Cal-MMET grant agreement, and this Board wishes to so authorize the Sheriff to execute the agreement.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Sheriff of the County of San Mateo is authorized, on behalf of the County of San Mateo, to execute the 2006/07 Cal-MMET Grant agreement with the California Office of Emergency Services, and to execute all related documents necessary to administer the Cal-MMET grant funds consistent with the County's 2006/07 Cal-MMET Grant application.**
