NOTICE OF PUBLIC MEETING

NOTICE IS HEREBY GIVEN that the San Mateo County Board of Supervisors will hold a public meeting on June 19, 2007 at which will be considered:

Adoption of a resolution amending selected Park and Marina Berthing Fee Schedules as follows: 1) increase general user fees for use of Jack Brook Horse Camp for small areas II and III from \$75.00 to \$80.00 for Friday and Saturday and from \$26.00 to \$30.00 for Sunday through Thursday; 2) increase cost of sack of firewood from \$8.00 to \$10.00, bundle of firewood from \$6.00 to \$8.00, and box of firewood from \$12.00 to \$15.00; 3) increase baseball field fees for practice time from \$64.00 to \$67.00 for adult league and from \$23.00 to \$25.00 for youth and school leagues; 4) increase baseball field fees for games from \$125.00 to \$130.00 for adult league and from \$45.00 to \$50.00 for youth and school league games; 5) increase maintenance fees (minimum charge / first hour) from \$105.00 to \$110.00 and (additional time per hour) from \$36.00 to \$40.00 per staff person per hour plus actual cost of materials and supplies needed; 6) increase non-educational, commercial filming fee from \$620.00 to \$640.00 per day/per park plus permits, documents, and any other actual costs including staff overtime; 7) increase educational, documentary, nonprofit filming from \$31.00 to \$32.00 per day/per park plus permits, documents, and any other actual costs including staff overtime; 8) increase non-educational, commercial still photo fee from \$210.00 to \$217.00 per day/per park plus permits, documents, and any other actual costs including staff overtime; 9) increase educational, documentary, nonprofit basic still photo fee from \$31.00 to \$32.00 per day/per park plus permits, documents, and any other actual costs including staff overtime; 10) increase fee per reservation change from \$5.00 to \$10.00 excluding change in number of additional participants, adding areas, rescheduling due to rain or facility unavailability; \$10.00 to cancel; 11) change reservation policy to make reservations for Toyon Campgrounds not-changeable and nonrefundable; and 12) increase Marina berth fees by 2.4 percent.

The meeting will commence at 9:00 a.m. on Tuesday, June 19, 2007 in the Board of Supervisors Chambers located at the Hall of Justice and Records, 400 County Center, Redwood City, California. This meeting will be open to the public and anyone interested may appear and be heard on this matter. All inquiries should be directed to David G.
