

**AMENDMENT TWO TO THE AGREEMENT BETWEEN  
THE CHILDREN'S HEALTH INITIATIVE AND  
THE SAN MATEO COMMUNITY HEALTH AUTHORITY  
TO ADMINISTER THE HEALTHY KIDS PROGRAM**

This Amendment is entered into this \_\_\_\_ day of May, 2007.

**WITNESSETH:**

**WHEREAS**, on February 12, 2005 the parties entered into an Agreement for the Health Plan to provide health insurance to Healthy Kids members for the period of February 12, 2005 to February 11, 2008 (hereafter "the Agreement") pursuant to its Resolution No. 067335; and

**WHEREAS**, contract rates are renewed on an annual basis and the capitation rate beginning February 12, 2007, is to be increased; and

**WHEREAS**, services related to dental utilization outreach will be included in the services provided beginning June 1, 2007 and will require an additional increase in the capitation rate; and

**WHEREAS**, the payment for the Healthy Kids Retention Specialist is to be modified; and

**WHEREAS**, the parties now wish to amend the Agreement.

**NOW, THEREFORE**, the parties agree that their Agreement for administration of the Healthy Kids Program is amended as follows:

1. Attachment B- Premium Schedule for February 12, 2006 through February 11, 2007, is hereby amended to read:

**Attachment B**

- A. Premium Schedule for February 12, 2007 through May 31, 2007; Premium per Member per Month is \$91.72.
- B. Premium Schedule for June, 1, 2007 through February 11, 2008; Premium per Member per Month is \$92.13."

2. Attachment C- paragraph C.2, last two sentences amended to read:

"PLAN will be paid an amount equal to the person's weekly salary and benefits amount for work performed per this Attachment, up to a maximum of \$53,031.00 for January 1, 2007 through February 11, 2008".

3. This Amendment shall be effective on January 1, 2007.

4. All other terms, conditions, and provisions of said Amendment shall remain in full force and effect so that all rights, duties, obligations and liabilities of the parties hereto remain unchanged.

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES,** that the Agreement of February 12, 2005 be amended accordingly, and that these Amendments are hereby incorporated and made a part of the original Agreement and any Amendments thereto, and subject to all provisions therein.
