I. Purpose of amendment:

This amendment implements a CDPH approved assignment of Grant agreement 04-35711 from one business entity to another.

II. By executing this amendment, CDPH and County of San Mateo expressly consent to assign and transfer all rights and interests in Grant Agreement 04-35711 to Teen Pregnancy Coalition of San Mateo County as of July 1, 2007. By executing this amendment, Teen Pregnancy Coalition of San Mateo County assumes all rights, duties, obligations, responsibilities, and liabilities of any type that accrue under Grant Agreement 04-35711 on or after July 1, 2007 and agrees to abide by the terms and conditions of said agreement.

III. By executing this amendment, CDPH expressly releases County of San Mateo from all obligations and liabilities that accrue under Grant Agreement 04-35711 on or after July 1, 2007.



IV. As of July 1, 2007, all references to County of San Mateo appearing in Grant Agreement 04-35711 and its exhibits shall be deemed to read Teen Pregnancy Coalition of San Mateo County.

V. Following execution of this amendment, Teen Pregnancy Coalition of San Mateo County shall provide written notification to CDPH's funding program of the names and telephone numbers of its Project Director and Financial Officer.
