This refers to the Lease accepted by the United States Postal Service, hereinafter called the Postal Service, under date of 07/01/1978, whereby there is leased to the Postal Service the above-described facility.

WHEREAS, the Postal Service desires and Landlord is willing to amend the Lease as specified below;

NOW THEREFORE, in consideration of the mutual covenants and agreements herein set forth, and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties do hereby agree as follows, effective on the date this document is executed by the Postal Service.

The lease is extended from July 1, 2008 through June 30, 2013 for an annual rental rate of \$40,000.

There is also added a second 5-year renewal option from July 1, 2013 through June 30, 2018 at an annual rental rate of \$45,000.

Added Termination Clause: No other provision of the lease withstanding, Landlord and/or U. S. Postal Service shall have the right at any time during the term, by signing not less than six months written notice to the other, to teminate this lease without penalty.
