

**ADDENDUM TO THE
ASSESSMENT REPORT**

Dated January 29, 2008

for

**Slope Stability Improvements
Within the Landslide Area
In Unincorporated La Honda Area
of San Mateo County**

(April 22, 2008)

INTRODUCTION

The Assessment Report dated January 29, 2008 (also referred to as the “Engineer’s Report” or the “Original Report”) was approved by the San Mateo County Board of Supervisors on February 12, 2008. The Original Report accurately described the scope of the proposed work and improvements, the cost of that work and improvements, and the boundaries and limits of the proposed assessment district.

Following the February 12, 2008, approval of the Original Report by the Board of Supervisors, two owners of tax assessor’s parcels identified as assessment units in Zone 1, came forward and each demonstrated that each tax assessor’s parcel in question was actually already a portion of another assessment unit. Accordingly, there are only 331 Zone 1 assessment units instead of 333 as earlier believed. This addendum provides the corrected calculations for the reduction in the number of assessment units. However, this addendum relies on a final assessment calculation that assumes that the County will contribute enough additional funds such that the final assessment amounts would be the same as if there were still 333 Zone 1 assessment units. The result is that for this addendum, each Zone 1 assessment is \$34.43 less than an assessment would be if based on 331 Zone 1 assessments; while a Zone 2 assessment is reduced by \$69.56.

CORRECTIONS

The information herein and in Appendices (C-1 and D-1) supersedes the information contained in the Original Report:

- There are 331 Zone 1 assessment units. This report and Addendum are based on each Zone 1 assessment unit being assessed \$6,029.73 for a total of \$1,995,839.09, which sum represents 93.8% of the total assessment of 2,128,533.41; and 32.6% of the total estimated cost of the improvements.
- There are 11 Zone 2 assessment units. This report and addendum are based on each Zone 2 assessment being assessed \$12,063.12 for a total of \$132,694.32, which sum represents 6.2% of the total assessment of \$2,128,533.41, and 2.2% of the total cost of the Improvements.
- Each of the 11 assessment units within Zone 2 will a 15-year annualized assessment payment that is twice as much as the 15-year annualized assessment payment for a Zone 1 assessment unit.
- The assessment calculations in this report are premised on the County contributing up to \$4,012,059.44, including any assessment, towards the cost of the proposed improvements, with the remaining \$2,110,440.56 to be funded by the impacted community through the assessment district. The Assessment District, which includes County-owned parcels for which the County will pay an assessment, is intended to fund \$2,128,533.41 of the costs for constructing the improvements. The County would provide \$18,092.85 as an assessed land owner in the assessment district, and an additional \$3,993,966.59.
- The proposed additional County contribution of \$12,059.44 will be expended as a “match” to the \$2,128,533.41 assessment district total in the ratio represented by those totals. Accordingly, based on an anticipated total cost of \$6,122,500, for every \$612.25 spent on the Improvements, \$212.85 will be assessment district funds and \$399.40 will be County “matching” funds. That is, for every \$1000 spent, approximately \$652 would come from the County’s additional contribution and \$348 would come from the assessment district. Any funds from a third party source (i.e., a grant or federal or state assistance) would be credited to the County or the District in the same proportions as are the expenditures.

The annualized assessments shown in the following table are calculated using the Capital Recovery Formula:

$$A = \text{Annual Assessment} = P [i (1+i)^N] / [(1+i)^N - 1]$$

where, P = Present Value of Total Property Owner Assessment per Parcel

i = Interest Compounded Annually = 5%

N = Total Number of Interest Periods = 15 years
