### Youth Commission

#### Who Is the Youth Commission:

A group of youth that advises and creates policy affecting youth in San Mateo County

#### **Advising and Creating Policy:**

- Review and make recommendations on policies impacting youth in San Mateo County
- 2) Evaluate, endorse, and make recommendations on programs which serve youth in San Mateo County
- Create a forum that is accessible to both youth and adults to discuss programs and policies affecting youth in San Mateo County
- 4) Engage youth and adults as equal partners to share information and resources to better serve San Mateo County



### Youth Commission

#### 41 Developmental Assets

- Youth Development framework
- Works to build all assets, main focus on:
- Other Adult Relationships
- Community Values Youth
- Youth as Resources
- Personal Power
- Positive View of Personal Future



### Updates on 2007 Adolescent Report

- Focus on two of the 2007 recommendations:
  - Violence Prevention
  - Comprehensive Sex Education
- "Setting the stage" and developing strategies for implementation
  - What resources are already available?
  - What is working well?
  - What other actions are needed?



# Updates: Violence Prevention

#### **Violence Prevention Recommendation:**

Initial focus on providing more job training programs for youth NOT on a college track

#### How we established these strategies:

- Determined what else we need to know
- Gathered information from job training resource providers

# **Updates: Violence Prevention**

#### **Strategies**

- Create a youth friendly web-site with access to info about job opportunities.
- 2) PSA campaign to promote this website to target audience.
- 3) Support a \*best practice model\* which builds skills in these youth.
- 4) Increase the number of paid internships available to youth.
- 5) Promote/support living wages for youth who complete job training courses.
- 6) ROP (Regional Occupational Program) expanded to schools throughout the county.

# **Updates: Sex Education**

#### **Sex and Sexuality Recommendation:**

Need for more comprehensive sex education

#### How we established these strategies:

- Defined "Comprehensive Sex Ed" standards
- Interviewed local experts on the subject
- Conducted a Fishbowl Forum to receive more youth feedback on their experiences with sex ed



# Updates: Comprehensive Sex Education

#### **Strategies:**

- 1) Providing and endorsing proven curriculum and training educators to deliver said curriculum in culturally appropriate manner.
- Ensuring schools are aware of the reimbursement that the State Department of Education pays to schools that provide HIV curricula.
- 3) Increase the number of peer education programs.
- 4) Explore Daly City Youth Health Center staff as providers to schools in the North County.

### Fishbowl Forums

#### Coordinated five Fishbowls in 2008:

- Mentoring
- Stress
- Sex Education
- Environment
- Violence



## Fishbowl Forums

#### **Common Themes:**

- Youth want to connect with adults, but building that relationship needs time and dedication
- Youth can learn and get engaged with creative and fun interaction with teachers and peers
- School, family, friends, stress, and violence are part of a cycle
- Creative forms of expression, like music, writing, and art are common ways to deal with stress
- More communication between youth and adults is key in dealing with issues
