## **Proposed Parking Zones:**

- 1. Establish Disabled Parking Zones at:
  - a) 575 Warrington Avenue
    - i. Justification: Resident Mr. Jose Sandoval has limited access to his property because neighbors and church members regularly park their vehicles in a manner that blocks full access to his driveway. Therefore, staff recommends assigning one disabled parking zone in front of his residence to allow his caregivers and emergency vehicles easier access to assist him.
    - b) 579 Hurlingame Avenue
      - i. Justification: Resident Mr. and Mrs. Daniel Bunn have limited access to their property because neighbors regularly park their vehicles in a manner that blocks full access to their driveway. Therefore, staff recommends assigning one disabled parking zone in front of their residence to allow caregivers and emergency vehicles easier access to assist them.
- 2. Establish 20-minute Time Limited Parking at:
  - a) 2200 Bay Road
    - i. Justification: A-Abco Medical Supplies, requests time limited parking in front of their business in order to discourage students from parking in front of his business during school hours. The 20 minute parking would allow a convenient parking space for his clients, many of whom come to purchase wheelchairs, canes, and other medical supplies for home use.
- 3. Establish 20-minute Time Limited Parking at:
  - a) 426 Mac Arthur Avenue
    - Justification: Accent Counters requested a reduction from 2 hours to 20 minutes in parking time to better serve their online counter top business. Customers are requested to make an appointment prior to visiting the showroom. Therefore, the proprietor of the shop feels that a 20-minute parking space would better serve her needs than the 2-hour parking space.

## Abolish Parking Zones:

- 4. Abolish Resolution No. 067697, adopted 12/06/05, in part:
  - a) 2-hour Time Limited Parking at 426 Mac Arthur Avenue
    - i. Justification: Accent Counters time zone modification described above.
- 5. Abolish, in part, Resolution No. 067696, adopted 12/06/05:
  - a) 1- hour Time Limited Parking on Pacific Avenue at the 2800 Middlefield Road address.
    - i. Justification: Osuna Auto Repair, located on the Pacific side of the property, requests to eliminate the 1-hour parking limit near the business in order to allow them to park vehicles on the street for longer periods of time.
- 6. Abolish, in part, Resolution No. 068090, adopted 06/20/06:
  - a) Loading Zone at 820 Sweeney Avenue
    - i. Justification: Hoffman Oliver paint store requests removal of a loading zone in front of their shop as the existing parking area, shared by several tenants on this property, does not provide sufficient parking space for his customers.
