AN ORDINANCE AMENDING SECTION 2.45.020 OF CHAPTER 2.45 OF TITLE 2 OF
 THE SAN MATEO COUNTY ORDINANCE CODE SETTING CORONER FEES

The Board of Supervisors of the County of San Mateo, State of California,

ORDAINS as follows

SECTION 1. Section 2.45.020 of Chapter 2.45 of Title 2 of the San Mateo Ordinance Code is hereby amended to read as follows:

Except as otherwise specifically provided by other ordinance or state law, the following fees shall be charged for services rendered by the Coroner as specified.

All cases brought into the Coroner's Office shall be billed for transportation, personnel handling, and storage costs, except for decedents under 14 years of age, homicides, and in custody or officer-involved cases. However, for all cases pouch or bags fees will be charged.

SECTION 3. This Ordinance shall be effective thirty (30) days from the passage date thereof.
