AN AMENDMENT TO THE AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND EDGEWOOD CENTER FOR CHILDREN AND FAMILIES

THIS AMENDMENT TO THE AGREEMENT, entered into this _____ day of

_____, 20____, by and between the COUNTY OF SAN MATEO,

hereinafter called "County," and EDGEWOOD CENTER FOR CHILDREN AND

FAMILIES (ECCF), hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on June 19, 2008, the Human Services Agency executed Agreement Number 74200-08-D022 in the amount of \$23,700 for the term April 7, 2008 through December 31, 2008, wherein ECCF agreed to conduct research on Family Finding Best Practices; and

WHEREAS, the parties wish to enter into an Amendment to add funds to provide a Family Finding Pilot Program for FY 2008-09 in the amount of \$161,316 for a new total obligation of \$185,016 and extend the term by six months, from April 7, 2008 through June 30, 2009;

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Exhibits and Attachments to the Agreement are hereby added to read as follows:

2. Paragraph 2: **Contract Term** is hereby amended to read as follows: The term of this Agreement shall be from April 7, 2008 through June 30, 2009 unless terminated earlier by the County. 3. Paragraph 3:**Payments** is hereby amended to read as follows:

In consideration of the services rendered in accordance with all terms, conditions and specifications set forth herein and in Exhibit "A1 and A2", County shall make payment to Contractor in the manner specified herein and in Exhibit "B and B1". In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination. The County reserves the right to withhold payment if the County determines that the quantity or quality of the work performed is unacceptable. In no event shall total payment for services under this Agreement exceed **ONE HUNDRED EIGHT FIVE THOUSAND AND SIXTEEN DOLLARS (\$185,016).**

4. All other terms and conditions of the Agreement dated June, 19, 2008 shall remain in full force and effect.

Scope of Work August 18, 2008 through June 30, 2009

I. Description of Services to be Performed by the Contractor

- In no event shall the total exceed ONE HUNDRED EIGHTY FIVE THOUSAND SIXTEEN DOLLARS (\$185,016) for the term of the Agreement. Payment shall be made within 30 days after approval by the Human Services Agency Program Manager.
- 3. County may withhold all or part of the Contractor's total payment if the Director of the Human Services Agency or her designee reasonably determines that Contractor has not satisfactorily performed the services described in Exhibits A1 and A2.
- 4. County will give thirty (30) days prior written notice to Contractor of County's intent to withhold payment.
- 5. If the County reasonably determines that the circumstances warrant immediate action, County may withhold payment immediately, without the thirty (30) day waiting period, upon County's written notice with justification to Contractor.
