- 3) Thence North 77° 14' 30" East along said District boundary and northerly line 11.19 feet to the intersection thereof with the northwesterly prolongation of the easterly line of Lot 1 of Lot 4, and an angle point in said district boundary;
- 4) Thence South 18° 37' East, leaving said northerly line and continuing along said district boundaries and said prolongation 30.16 feet, to a point in the southerly line of Esther Lane;
- 5) Thence North 77° 14' 30" East, leaving said District boundary and continuing along said southerly line, 138 feet;
