AMENDMENT NO. 1 TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND SYNTELLECT, INC.

called "County," and SYN	NTELLECT, INC., hereinafter called "Contractor";

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for providing software support and maintenance services for the Vista Framework as well as professional services as needed for system modifications and enhancements on August 1, 2007; and

WHEREAS, the parties wish to amend the Agreement to add ONE-HUNDRED NINETY-SIX THOUSAND NINE-HUNDRED FORTY-EIGHT DOLLARS (\$196,948), for a new not to exceed amount of THREE-HUNDRED TWENTY-THREE THOUSAND ONE-HUNDRED THIRTY-TWO DOLLARS (\$323,132).

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3 of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions and specifications set forth herein and in Exhibit "A," County shall make payment to Contractor based on the rates and in the manner specified in Exhibit "B." The County reserves the right to withhold payment if the County determines that the quantity or quality of the work performed is unacceptable. In no event shall the County's total fiscal obligation under this Agreement exceed THREE-HUNDRED TWENTY-THREE THOUSAND ONE-HUNDRED THIRTY-TWO DOLLARS (\$323,132).

- 2. Original Exhibit A is amended to add the following items after item 3):
 - 4) Professional services including Design Services, Integration Services, Voice Services, and Education Services.
 - 5) Thirty (30) Interaction Type Seat licenses for iTypes including: Interaction Handling, Inbound Voice licenses, Outbound Voice licenses, Voice Mail licenses, Interaction

Monitoring licenses, Report Manager licenses, Interaction History licenses, Queued Interaction Manager licenses, Port licenses, one (1) Switch Link license, one (1) Event Publisher license, and one (1) Switchlink Voice Interface license.

- 6) Hardware to include one (1) 48-Port NMS CG6060-2T1/E1 1600 MIPS card and two
- (2) AI-Logic NGX 2400- 24 port digital line tapping boards.
- 7) Maintenance shall include a one-year Premium Service Level Agreement, which includes 24-hour-a-day, 7-days-a-week hardware maintenance support with priority routing and premier Service Level Agreement (SLA).
- 3. Original Exhibit B is amended to replace the language "In no event shall the total agreement amount exceed \$126,184" with the following items and language:
