WHEREAS, the parties entered into an Agreement for consulting services relating to the mainframe migration on November 1, 2007;		
WHEREAS, the parties wish to amend the Agreement (1) to add up to FIFTY THOUSAND DOLLARS (\$50,000), for a new total maximum obligation of ONE-HUNDRED FORTY-NINE THOUSAND DOLLARS (\$149,000), and (2) to extend the term of the Agreement to June 30, 2009.		
NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:		
1.	Section 2 of the Agreement is amended to read as follows:	
	The term of this Agreement shall be from November 1, 2007, to June 30, 2009, unless terminated earlier by the County.	
2.	Section 3 of the Agreement is amended to read as follows:	
	In consideration of the rendered in accordance with all terms, conditions and specifications set forth herein and in Exhibit "A", County shall make payment to Contractor in the manner specified herein and in Exhibit "A". In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess	

DOLLARS (\$149,000).

of the amount owed by the County at the time of contract termination. The County reserves the right to withhold payment if the County determines that the quantity or quality of the work performed is unacceptable. In no event shall the total payment for services under this Agreement exceed ONE-HUNDRED FORTY-NINE THOUSAND

3. The third paragraph of Section II, Amount and Method of Payment, of Exhibit "A" to the Agreement is amended to read as follows:

In no event shall the total payment for services under this Agreement exceed ONE-HUNDRED FORTY-NINE THOUSAND DOLLARS (\$149,000). The County has the right to withhold payment if the County determines that the quality of work performed is unacceptable.

4. All other terms and conditions of the Agreement dated November 1, 2007, as amended, between the County and Contractor shall remain in full force and effect.
