BACKGROUND:

Supervisor Jerry Hill was elected to the State Legislature and resigned his seat, creating a vacancy on the Board as of December 1, 2008. Section 203 of the County Charter sets forth the process for filling Board vacancies and gives the Board the option of either calling an election or making an appointment of an individual to serve the remainder of the current term of office.

At its November 18, 2008 meeting, the Board decided to commence a process for considering the appointment of a successor to Supervisor Hill, with the final decision as to whether to appoint and who to appoint to be made at the Board's regular meeting of December 16. The process as approved included the making of

presentations by and on behalf of the applicants and public testimony at today's special meeting of the Board.

DISCUSSION:

Jackie Jacobberger, Director, League of Women Voters of North and Central San Mateo County will be facilitating the meeting. The process will be as follows:

- 1. Explanation of the presentation process by Ms. Jacobberger.
- 2. Drawing by lot or similar method of the names of the applicants by Ms. Jacobberger to determine the order of presentations.
- 3. Presentations by each applicant of up to 15 minutes, immediately followed by testimony of up to 10 minutes by supporters of that applicant (as organized by, or on behalf of, the applicant).
- 4. Public comment on the appointment of up to 2 minutes per speaker (to be taken after conclusion of all applicant and supporter presentations).
- Board Member discussion.

The decision as to whether to appoint and who to appoint, or whether in the alternative to call an election, is scheduled for the Board's regular meeting on December 16.
