Approve an Appropriation Transfer Request (ATR) in the amount of \$998,150 from Non-Departmental General Fund Reserves to Salaries and Benefits and Services and Supplies within the Elections Budget Unit to fund the Presidential General Election held on November 4, 2008.

This ATR contributes to the commitment and goal by providing additional funds to meet the historical record number of voters participating in the Presidential General Election.

#### BACKGROUND:

Each department within the County is required to balance its budget at the object level within each respective budget unit. The Elections Division has the sole responsibility to conduct elections on behalf of the voters of San Mateo County.

The November 4, 2008 Presidential General Election was one of the most historic elections in recent years as it captured the interest of a large number of new and younger voters. It was, accordingly, the most expensive countywide election ever
