AMENDMENT NO. 1 TO THE AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND eCLINICAL WORKS, LLC

WITNESSETH:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement to install and maintain an Ambulatory Electronic Medical Record (AEMR) at the San Mateo Medical Center (SMMC) on January 8, 2008; and

WHEREAS, the parties wish to amend the Agreement to add \$700,000 to the Agreement, for a new total maximum fiscal obligation of no more than \$2,500,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 1 of the Agreement is amended to read as follows:

The definition of "License Fee" shall be amended to read as follows:

"License Fee" shall mean a one-time fee charged for each Provider License except for Resident Licenses, for which an annual fee is charged. Where a Provider License is required for a non-Provider to perform certain system functions (such as a Nurse, except for Nurse Practitioners, signing a chart), additional Provider Licenses shall be provided at no cost to County for such non-Providers.

The definition of "Provider(s)" shall be amended to read as follows:

"Provider(s)" shall mean Physicians, Nurse Practitioners, Physicians' Assistants, Optometrists, Physical Therapists, Psychologists, Dentists, Hygienists, Midwifes, Nutritionists, Podiatrists, Licensed Social Workers, Counselors, and Audiologists employed by or under contract with the County to provide services within the medical field and for whom the County is paying a License Fee as set forth in this Agreement. The term Provider shall not include County personnel employed by or under contract with the County such as office managers, secretaries, other administrative staff, Dentists, Nurses (other than Nurse Practitioners), or

Residents. For a category not identified above, Contractor and County shall agree in writing as to who is a Provider.

The following definitions are added:

"Resident(s)" shall mean a "physician in training" who is unable to practice without supervision or countersignature and is employed by or under contract with the County to provide services within the medical field and for whom the County is paying an annual Resident License Fee as set forth in this Agreement. Due to the rotation of Residents, more than one Resident may use the same Resident License during the annual period.

"Dentist(s)" shall mean a healthcare professional (DDS or DMD) employed by or under contract with the County qualified to practice dentistry after graduating with a degree from an accredited School of Dentistry and having a State license to practice dentistry. A FTE Provider License is granted at no charge for a Dentist to use the Software Products as described in Section 4 of Exhibit A to the Agreement. If County purchases EPM, as provided for in Section 7 of Exhibit B to the Agreement, EPM licenses for dentists will need to be purchased. If Contractor in the future develops an EMR for dentists, County will have the option to purchase EMR licenses for the dentists.

2. Section 4 of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth herein and in Exhibit "A," County shall make payment to Contractor based on the rates and in the manner specified in Exhibit "B." The County reserves the right to withhold payment if the County determines that the quantity or quality of the work performed is unacceptable. The County's total fiscal obligation under this Agreement shall not exceed \$2,500,000 over the entire Term.

3. Section 23 is added to the Agreement to read as follows:

23. Employment Non-Solicitation

Contractor and no person of hiring authority within San Mateo Medical Center and Information Services Department will solicit the employment of the other party's employees during the term of the support under this agreement, without the express written consent of the other party.

4. Original Exhibits A and B are amended to include the following, (rev. March, 2009).

All references in the Agreement to FTE Providers shall be changed from 72 to 100.

All references in the Agreement to Named Providers shall be changed from 160 to 296.

26 Residents Licenses are added to the Agreement.

18 Dentists Licenses (no charge) are added to the Agreement.
