
## **Descriptions of Proposed Traffic Control Devices by Location:**

New Yield Sign on 18th Avenue at the intersection with Bay Road, North Fair Oaks

Discussion: Residents requested that staff study this intersection for a stop sign or yield sign. Staff verified that this location qualifies for a yield sign as follows:

- A. Sight distance restricted on 18<sup>th</sup> looking left
- B. Bay Road is a collector street
- C. Traffic traveling eastbound on 14<sup>th</sup> to southbound Bay do not stop


Figure A. Location Map with Proposed Yield Sign and Existing Intersection Control near 18<sup>th</sup> Ave.



New 20-minute Time Limited Parking Zone at 2220 Bay Road, North Fair Oaks

Discussion: The owner of the business at this address asked for a 20-minute Time Limited Parking Zone. Staff reviewed the site and determined that:


- A. The 20-minute parking would allow a convenient parking space for his clients
- B. The business does not have a parking lot
- C. The new 20-foot parking zone will not negatively impact neighborhood parking



New 20-minute Time Limited Parking Zone on Buckingham Avenue near El Camino Real, North Fair Oaks

Discussion: The business owner at 2701 El Camino Real (a corner lot) requests a 20-minute Time Limited Parking Zone on Buckingham Avenue to better serve his businesses. Staff reviewed the site and recommends establishing time limited parking because of the following:

- A. The 20-minute parking would allow a convenient parking space for his clients
- B. There is no off-street parking available
- C. One 20-foot new parking zone will not negatively impact neighborhood parking




Changes to No Parking Zone on Northside Avenue, North Fair Oaks
Discussion: The business located at 2747 Northside Avenue in
North Fair Oaks requested changes to the existing No Parking
Zone across the street from the property. The new parking
arrangement is proposed as follows (from west to east):

- A. 115 feet long Existing No Parking Zone
- B. 135 feet long New 20-minute Time Limited Parking
- C. 66 feet long New No Parking Zone

Staff reviewed the site and recommends the changes because of the following:

- A. The new 20-minute Time Limited Parking zone will suit the business's needs
- B. The new No Parking Zone will aid the truck drivers in their turning movement between Hampshire Avenue and Northside Avenue
- C. The new parking zone arrangement will not negatively impact neighborhood parking



Changes to Time Limited Parking Zone at 377 87<sup>th</sup> Street, Broadmoor Discussion: The church located at 377 87<sup>th</sup> Street in Broadmoor requested changes to their existing 1-hour Time Limited Parking Zone in front of the property to better serve the congregation. The new parking arrangement is proposed as follows (from west to east):

- A. 30 feet of 2-hour Time Limited Parking
- B. 27 feet of 5-minute Drop-Off Zone
- C. 53 feet of 2-hour Time Limited Parking

Staff reviewed the site and recommends the changes because of the following:

- A. The 2-hour parking more appropriately corresponds to the church service length
- B. The new 5-Minute Drop-Off Zone is located in front of the church entrance, so disabled patrons will have a shorter trip
- C. There is no off-street parking available to the congregation
- D. The new parking zone arrangement will not negatively impact neighborhood parking
