FIRST AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND Mazzetti & Associates

THIS AMENDMENT TO THE AGREEMENT, entered into this _____ day of

_____, 20____, by and between the COUNTY OF SAN MATEO, hereinafter

called "County," and Mazzetti & Associates, hereinafter called "Contractor";

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on July 22, 2008, the parties entered into an Agreement for Mechanical and Electrical Professional Consulting services; and

WHEREAS, the parties wish to amend the Agreement to increase the County's maximum fiscal obligation by \$100,000, for a new agreement total not to exceed \$300,000.

NOW, THEREFORE, IN CONSIDERATION OF THE ADDITIONAL SERVICES THAT HAVE BEEN PROVIDE BY CONTRACTOR, PURSUANT TO COUNTY AUTHORIZATION, THE AGREEMENT IS HEREBY AMENDED AS FOLLOWS:

1. Section 3 of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions and specifications set forth herein and in Exhibit "A", County shall make payment to Contractor based on the rates and in the manner specified in Exhibit "B." The County reserves the right to withhold payment if the County determines that the quantity or quality of the work performed is unacceptable. In no event shall the County's total fiscal obligation under this Agreement exceed Three Hundred Thousand Dollars, \$300,000

2. Original Exhibit B, Section 3 is replaced with Revised Exhibit B, Section 3, (rev. [March 26, 2009]).

The total not –to-exceed amount for this Agreement shall be \$300,000 unless said amount is authorized to be increased by the county Board of Supervisors. Specific projects that may be assigned to the Contractor shall have individual not-to-exceed amounts as stated in the proposal/task order. The sum of individual proposal/task order not-to-exceed amounts as stated in the proposal/task order. The sum of individual proposal/task order

not-to-exceed fees for multiple projects that may be assigned to the Contractor shall not exceed the total \$300,000 not-to-exceed amount for this Agreement without prior written approval by the County Board of Supervisors.

3. All other terms and conditions of the agreement dated the 22nd day of July, 2008, between the County and Contractor shall remain in full force and effect.
