HIP Housing strongly supports the County of San Mateo's "Substantial Amendment to the Consolidated Plan 2008 Action Plan for Homelessness Prevention and Rapid Re-Housing Program (HPRP), and the process for expediting the allocation of funds.

HIP Housing also appreciates the opportunity to comment on the Amendment of the Homelessness Prevention and Rapid Re-Housing Program (HPRP). In reviewing the Amendment, we believe the plan is a critically needed supplement to San Mateo County's needs, given the current economic downturn. As calls to HIP Housing have increased by over 30% over the last six months, it is clear more funds are needed to help those who are homeless or at-risk of homelessness.

In regards to the general use of funds, HIP Housing has two programs within the guidelines of HPRP: its Home Sharing Program and its Self-Sufficiency Program. The Home Sharing Program and Self-Sufficiency Program both assist: 1) Individuals and families in San Mateo County currently housed who are at-risk of becoming homeless with rental assistance and/or assistance to move to another unit, and 2) Individuals and families who are homeless and need assistance to obtain and retain housing.

If HIP Housing has the opportunity, we would participate in the Homelessness Prevention and Rapid Re-Housing Program in the following categories:

In the category of Financial Assistance:

- Assist people with short and medium term rental assistance.
- Assist people with security deposits.

In both our Home Sharing Program and Self-Sufficiency Program clients have a need for rental assistance and security deposits, which will help these individuals to transition from homelessness (or risk of homelessness) to stable housing.
