	Claimant alleges lost personal property while at the Northern San Mateo Courthouse.

G08-090	Garcia, Flor	6/8/09	Non-culpable Claimant alleges her vehicle was towed while parked on private property in Woodside.
G08-087	Garcia, Omar	4/4/09	Non-culpable Claimant alleges during his incarceration at the San Mateo County Jail, his personal property was removed from his cell.
A08-067	Johnson, Scott	6/10/09	Non-culpable Claimant alleges his vehicle was hit by a San Mateo County vehicle on 3rd Street in Montara.
G08-088	Morgan, Pamela	2/09-3/16/09	Non-culpable Claimant alleges she suffered great emotional trauma and was denied medical care during her incarceration.
G08-085	Podaras, N. Charles	12/9/08	Non-culpable Claimant alleges misconduct by employees of the San Mateo County District Attorney's Office has directly caused significant harm and damage to his reputation and in finding and/or maintaining employment.

G08-050	Smith, Adrian and Kathleen	1/22/09	Non-culpable Claimants allege ongoing threat of sewage backup at 2 Wilmington Acres Court in Emerald Hills is due to the failure to fix the main sewer line and implement proper maintenance programs.
