**SUBJECT:** Resolution for Delinquency Prevention Commission

**RECOMMENDATION:**

Adopt a Resolution:

- A) Establishing four year terms of service for the members of the Delinquency Prevention Commission, which shall begin on January 1 in the year in which the member was appointed and first attended a meeting as a member of the Commission, and which shall end on December 31 four years thereafter.
- B) Except as stated herein or as directed by the Superior Court, the Delinquency Prevention Commission will comply with all standing rules and county boards commission and advisory committees.

**BACKGROUND:**

Section 2.47.030 of the San Mateo County Ordinance Code provides that members of the Juvenile Justice Commission of San Mateo County serve as the County Delinquency Prevention Commission. The Superior Court has responsibility for the Juvenile Justice Commission and the Board of Supervisors has responsibility for the Delinquency Prevention Commission.

**DISCUSSION:**

The Juvenile Justice and Delinquency Prevention Commission recognizes the importance of its role as the Delinquency Prevention Commission. The Superior Court has concurred with the Commission's desire to be guided in its operations by the standing rules established for county boards, commissions, and advisory



committees including Resolution No. 069276.

To the extent that starting dates for appointments vary and Commission business is conducted on a calendar year basis, the Commission has requested that the start date of each member's term are January 1 for the year that the Commission Member was appointed and first attended a meeting as a member of the Commission. The corresponding end date for each Commission Member's term will be December 31, four years thereafter.

The application of this change will result in the following term completion for current Commission Members:
