Reductions Already Made FY 2008 through FY 2010 Adopted Budget

- Closed morgue on all holidays
- Changed schedules of Deputy Coroners and Autopsy Technicians to minimize overtime or extra help
- Voluntary Time Off taken for 8 of 11 eligible full-time employees
- Use of one-person removal instead of two-person removal on certain types of cases
- Hired two Deputy Coroners at entry level
- Reduced rent by surrendering office space



Planning and Priority-Setting Process

- Who Was Involved?
 - Employee input
- Budget Scenario Planning Process
 - Examine all services provided
 - Determine services that could be combined, eliminated or reduced
- Criteria Used to Develop Budget Reductions
 - Examine impact to families, public safety, funeral homes, public
 - Core services analysis—all services are mandated
 - Workload and performance trends-workload increasing
 - Other criteria-reduce overhead costs



Mandated Services

Coroner MUST Provide:

- Death investigation and safeguard property
- Identification of decedents and notification of legal next-of-kin
- Determination of mode, manner and cause of death, including Sudden Infant Death Syndrome (SIDS)
- Toxicology testing
- Administrative and supervisory services

Discretionary Services

- Save-A-Life Program
- Trauma Bear Program
- Other community based programs
 - "Every 15 Minutes"



• Implementation July 1, 2010

- Reducing vehicles by two = \$7,600
- Performing presumptive testing before toxicology sent out
 \$21,371
- Conducting suicide toxicology only when suspected drug or carbon monoxide = \$9,654
- Reducing extra help, overtime, training = \$53,718
- Fee increase, number of cases increased = \$57,150
- Reducing operating costs = \$31,712

Impact

 Families of suicide victims will not always be able to know if drugs or alcohol were a factor
