NOTIFICATION OF FINAL LICENSE BOARD DECISION AND APPROVAL OF BUSINESS LICENSE

On October 18, 2010, the San Mateo County License Board considered your application for a business license to operate a Medical Marijuana Collective at the following locations: 2676 Bay Road, 2688 Bay Road, and 881 Hurlingame Avenue, Redwood City, CA 94063, in unincorporated San Mateo County.

At that meeting, the public was given an opportunity to address the Board with any information they wished to present, or any comments they wished to make. The Board took action and approved your application, finding that it complied with San Mateo County Ordinance Code Chapter 5.148 (Regulation of Collective Cultivation and Distribution of Medical Marijuana) subject to the following conditions of approval:

1. The applicant is required to comply with Chapter 5.148 of the County Ordinance Code, including all conditions of license indicated in Section 5.148.050.
2. Prior to commencing operations, the applicant shall obtain and complete all the necessary requirements for a building permit from the Planning and Building Department. The building permit shall comply with the plans and documents submitted for review at the October 18, 2010 License Board's public hearing. Any deviations from the plans will require review by the License Board at a public hearing.

Pursuant to Ordinance Code Section 5.04.230, within fifteen (15) days from receipt of this notice of license approval by the License Board, any member of the public

The medical marijuana collective will be operated or located in or within one thousand 1,000) feet of the Mental Health Association of San Mateo Counties, Spring Street Shelter, 2686 Spring St. The Spring Street Shelter provides emergency shelter and support services for homeless adults and emancipated minors with mental illnesses. Provides shelter to domestic abuse victims, and other services. The medical marijuana collective is detrimental to the residents and visitors. Many are children.

5.148.040 Requirement of and application for County license

(1) The requested use at the location 2676 Bay Road Redwood City ca will adversely affect the economic welfare of the nearby community. There are a large number of licensed and unlicensed daycare providers, retail and commercial businesses in this area. The collective will deter business away from the area.

- (2) The requested use at the location 2676 Bay Road Redwood City ca will adversely affect the use of properties used for a school, playground, park, youth facility, child care facility place of religious worship, or library. This area has the largest number of children and families in San Mateo County as evidenced by the many parks and schools and recreation centers, Hoover school, recreation field and swimming pool. Summit Preparatory Charter High School. Fair Oaks Elementary School, health center and playground. Taft Elementary School and playground. Andrew Spinus Park and playground. Fair Oaks Library and Community Center. Police Athletic league Community Center. Celebration Christian Fellowship, First Free Methodist Church, The Potters House Christian Fellowship Church.
- (3) The requested use at the location 2676 Bay Road Redwood City ca is not Sufficiently buffered in relation to any residential area and will adversely affect Said area.

This area has one of the highest population of children and families in San Mateo county. A large low to mid income Hispanic population. The approval of the application places the community at risk. An application for the location at 2991 El Camino Real Redwood City was denied in May 2010 by the licensing board. This area near Atherton, California, has a mainly White population and low population of low to mid income children and families. Also few schools parks and recreation centers. The San Mateo County licensing board incorrectly approved the application for the Sans Souci Medical Collective. There is no logic approving the collective in an area with so many children , who walk past the collective location going to school, parks and shopping and the many churches. Traffic and noise will increase. DUI's driving under the influence of marijuana will increase in the area. Crime will increase in the area. Other collectives have been closed by law agencies, because of illegal activity. Collectives have been robbed and burglarized. The collective will also lower residential and commercial property values and rental rates.
