SUBJECT: Continuation of Contracts

RECOMMENDATION:

Adopt a Resolution authorizing the Controller to continue payments on Health System contracts from July 1, 2011 through December 31, 2011.

BACKGROUND:

To ensure continued provision of services during the period following the adoption of the annual budget, it is necessary to authorize the Controller to continue to make payments to contractors at the existing rates. On June 7, 2011 your Board approved Resolution 071543 that allowed continuation of payments to selected contractors through September 30, 2011. The Health System has one contract for services that is still pending completion. A contract with California Emergency Physicians, listed in the Resolution, will be completed and submitted by the end of December 2011.

DISCUSSION:

This extended resolution allows the contractor to provide necessary services in a timely fashion and will allow the Health System the time needed to complete complex negotiations. All the terms and conditions shall remain in effect during the term of the continuing resolution.

The contract included in the Resolution is for services provided at San Mateo Medical Center. The contract has been in negotiation since April 2011. The issues that surround the negotiations define best practices for quality service delivery. We expect to bring this contract to your Board by December 13, 2011.

County Counsel has reviewed and approved the Resolution as to form.

Approval of this Resolution contributes to the Shared Vision 2025 outcome of a Healthy Community by enabling the Health System to continue to provide a continuity of services to the community until final negotiations can be completed.

FISCAL IMPACT: Funds for the annual costs of this contract has been included in the Health System FY 2011-12 Recommended Budget.

WHEREAS, this Board wishes to continue payments to contractors listed in

Attachment A through December 31, 2011, pending execution of a new Agreement.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

Board authorizes the Controller to continue payments through December 31, 2011 on said Agreement for and on behalf of the County, subject to the contractor's continued compliance with all terms and conditions of the most recently approved agreement with the County, with the exception of the maximum payment term provision. Said payments are to be at the existing rates in the most recent agreement with the County.
