- **SUBJECT:** Donation to San Mateo County California Children's Services Medical Therapy Program

RECOMMENDATION:

Adopt a Resolution:

- A) Accepting a donation of an adapted bicycle for use in California Children's Services Medical Therapy Program Medical Therapy Units; and
- B) Authorizing the Director of Family Health Services to execute, on behalf of the County of San Mateo, the Disclaimer, Release of Liability and any further agreements with The Variety Children's Charity in connection with the donation.

BACKGROUND:

California Children's Services (CCS) Medical Therapy Program (MTP) provides Occupational and Physical Therapy to children with eligible medical conditions; including (but not limited to): cerebral palsy, spina bifida, muscular dystrophy, rheumatoid arthritis, spinal cord injuries, arthrogryposis, and osteogenesis imperfecta.

CCS therapists help children learn the skills they need for daily life. The therapists use fun activities so therapy seems more like play than work. Therapists work on improving mobility and functions such as rolling, crawling, sitting, walking and using a wheelchair or walker.

DISCUSSION:

Variety Children's Charity has offered CCS MTP a donation of a Freedom Concepts Balance Bike. This adapted bicycle would be used as part of the therapy program to help children develop strength, balance and reciprocal leg movements all of which will contribute to their ability to move about in their environments. Variety Children's Charity has conditioned its donation of the adapted bicycle upon the County's execution of a Disclaimer and a Release of Liability. The Resolution and the Disclaimer and Release of Liability have been reviewed and approved by County Counsel.

Approval of this Resolution contributes to the Shared Vision 2025 outcome of a Healthy Community by providing an adapted bicycle to help children with CCS medical conditions improve mobility. It is anticipated that the activities of the CCS program will result in 95% of families reporting improvement.
