2011 WOMAN OF THE YEAR

WHEREAS, it has come to the attention of the Board of Supervisors of the County of San Mateo, State of California, that LAVERNE SEILER is being honored at Millbrae's 2011 Millbrae Man & Woman of the Year Awards Dinner for outstanding voluntary service to the community; and

WHEREAS, LAVERNE SEILER has lived in Millbrae for over 50 years, and started her many years of volunteer service at Green Hills Elementary, Taylor Middle School and Capuchino High School, where she was an active member of all three school PTAs, serving as chairwoman for several fundraising committees and PTA events for all three schools; and

WHEREAS, LAVERNE SEILER was a member of the Millbrae Chapter of AARP where she served on several commissions, and was "Sunshine Chairwoman" for her chapter, sending cards of cheer and greetings to members and families. After the Millbrae Chapter of AARP closed, LAVERNE SEILER, as a respected leader in the senior community, was instrumental in helping over 50 members transition to the San Bruno Chapter; and

WHEREAS, LAVERNE SEILER helps prepare and staff the Senior Center glass and token booth at the Annual Art & Wine Festival every year. LAVERNE SEILER recruits and organizes seniors months in advance to work in the booth on Labor Day Weekend and supervises the booth during the festival, and in addition helps to staff another senior booth which sells handmade crafts; and

WHEREAS, LAVERNE SEILER is an outstanding community member with a long list of volunteer accomplishments, including volunteer receptionist at the Millbrae Senior Center, co-coordinator of the Brown Bag Program which provides over 90 bag lunches to low-income seniors per week, Member-at-Large on the Millbrae Senior Advisory Committee, and in 2006 was recognized by the California Park and Recreation Society as Volunteer of the Year for her outstanding service with the Millbrae Senior Center.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of San Mateo, State of California, on this 13th day of October, two thousand and eleven, hereby honors and commends LAVERNE SEILER as Millbrae's 2011 Woman of the Year for her outstanding volunteer service.
