- **SUBJECT:** Amendment to the Agreement with the Department of Veterans Affairs Palo Alto Health Care System

RECOMMENDATION:

Adopt a Resolution authorizing the:

- A) President of the Board to execute an Amendment to the Agreement with the Department of Veterans Affairs Palo Alto Health Care System for the provision of space and resources for Willow Clinic and Methadone Treatment Program, extending the term by six months to February 10, 2012, and increasing the maximum amount payable by \$311,110.32 to an amount not to exceed \$3,916,952.32; and
- B) Chief of the Health System or designee to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.

BACKGROUND:

In March 1997, your Board approved a Sharing Agreement with the Department of Veterans Affairs Palo Alto Health Care System (VAPAHCS) for space in Building 334 on the VAPAHCS Menlo Park campus to locate and operate the Willow Clinic. Your Board approved subsequent Amendments and Supplemental Agreements to secure additional space for services such as the Methadone Treatment Program. In October 2006, your Board approved a five-year Agreement for the term August 11, 2006 through August 10, 2011, for continued County operations at the VAPAHCS Willow Campus. The clinic has been operational since that time. On September 27, 2011, your Board approved Resolution 071663 to continue authorizing payments to the VAPAHCS through February 10, 2012, while terms of a new lease could be finalized.

DISCUSSION:

The County is developing a consolidated South County Clinic at the Fair Oaks Clinic site in unincorporated Redwood City. It is anticipated that consolidation of the Willow Clinic at that site will be accomplished in July 2013. In the interim, a six month lease extension at the VA campus is required for the provision of space and resources at the Willow Clinic and Methadone Treatment Program, and VAPAHCS has agreed to extend the Sharing Agreement for an additional six months. This will allow VAPAHCS the time to write a separate agreement for each program. These new agreements will be presented to your Board for approval as we receive them from VAPAHCS.

The operation of the Methadone Clinic will transition to another provider upon completion of its licensing with the State and with the Drug Enforcement Agency. At that time an arrangement will be made to transfer the remaining term of the lease (along with other program details and client records) to the other provider in order to assure continuity of services to clients.

County Counsel has reviewed and approved this Agreement and Resolution as to form. The Contractor's insurance has been reviewed and approved by Risk Management.

The Contractor has assured compliance with the County's Contractor Employee Jury Service Ordinance, as well as all other contract provisions that are required by County ordinance and administrative memoranda, including but not limited to insurance, hold harmless, non-discrimination and equal benefits.

This Agreement contributes to the Shared Vision 2025 outcome of a Healthy Community by continuing to provide health services for patients at the Willow Clinic and at the Methadone Clinic. It is anticipated that patient satisfaction results will increase from 81% to 83%.

FISCAL IMPACT:

The Amendment extends the term of the Agreement by six months to February 10, 2012, and increases the maximum amount payable under the Agreement by \$311,110.32, to a maximum obligation of \$3,916,952.32. Funds in the amount of \$311,110.32 are included in the SMMC Adopted FY 2011-12.

Expenses at SMMC are covered by fees for services or third-party payors whenever possible. The portion of expenses for services provided to the medically indigent or to those covered by programs that do not meet the full costs of care are covered by the County's General Fund contribution to SMMC.

RESOLUTION AUTHORIZING THE A) PRESIDENT OF THE BOARD TO EXECUTE AN AMENDMENT TO THE AGREEMENT WITH THE DEPARTMENT OF VETERANS AFFAIRS PALO ALTO HEALTH CARE SYSTEM FOR THE PROVISION OF SPACE AND RESOURCES FOR WILLOW CLINIC AND METHADONE TREATMENT PROGRAM, EXTENDING THE TERM BY SIX MONTHS TO FEBRUARY 10, 2012, AND INCREASING THE MAXIMUM AMOUNT PAYABLE BY \$311,110.32 TO AN AMOUNT NOT TO EXCEED \$3,916,952.32; AND B) CHIEF OF THE HEALTH SYSTEM OR DESIGNEE TO EXECUTE CONTRACT AMENDMENTS WHICH MODIFY THE COUNTY'S MAXIMUM FISCAL OBLIGATION BY NO MORE THAN \$25,000 (IN AGGREGATE), AND/OR MODIFY THE CONTRACT TERM AND/OR SERVICES SO LONG AS THE MODIFIED TERM OR SERVICES IS/ARE WITHIN THE CURRENT OR REVISED FISCAL PROVISIONS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of

California, that

WHEREAS, a Sharing Agreement between the County and the United States

Department of Veterans Affairs (VA) allowing the County to use space and services at

the VA's Palo Alto Health Care System (VAPAHCS) campus for the County's Willow

Clinic, the Methadone Treatment Program, and related programs expired on August 10,

2011; and

WHEREAS, a renewal to this Agreement is being negotiated; and

WHEREAS, on September 27, 2011, this Board approved Resolution 071663 authorizing payments to the VAPAHCS through February 10, 2012, while terms of a new lease are negotiated; and

WHEREAS, VAPAHCS has agreed to extend the Willow/Methadone Clinic Sharing Agreement for six months through February 10, 2012, to allow the parties to negotiate agreements for both programs; and

WHEREAS, both parties now wish to amend the Agreement by extending the term by six months, to February 10, 2012, and increasing the maximum amount by \$311,110.32, to an amount not to exceed \$3,916,952.32; and

WHEREAS, this Board has been presented with a form of such Amendment to the Sharing Agreement, has examined and approved it as to both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of this Board of Supervisors be and is hereby authorized and directed to execute said Amendment to the Sharing Agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of the Health System or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
