SUBJECT: Appointment of David John Irwin to the Board of Directors of the

Westborough Water District

RECOMMENDATION:

Adopt a Resolution Appointing David John Irwin to the Board of Directors of the Westborough Water District.

BACKGROUND:

The Westborough Water District supplies water to consumers in an area that specifically covers parts of South San Francisco. The District's service territory covers approximately one square mile and serves approximately 12,000 people.

The Westborough Water District has five members on its Board of Directors. Three of those seats were up for election at the November 6, 2011 consolidated election and there were only two candidates. Pursuant to Elections Code § 10515, these two candidates shall be appointed by the "supervising authority" which, in the case of a special district, is the Board of Supervisors.

In regards to the third seat, for which there was no candidate, the Board shall also make this appointment pursuant to Elections Code § 10515. The Elections Code does not set forth a deadline for the Board to make this appointment nor does it set forth a required process for the Board to use to make the appointment. The only requirement is that the appointee must be a registered voter within the District as of November 6, 2011.

At its November 1, 2011 meeting, the Board adopted the following appointment process:

- (1) The District will provide reasonable notice and opportunity to apply to any person desiring to seek the appointment.
- (2) The District Board will forward to the Clerk of the Board of Supervisors a list of all candidates and their applications, and shall recommend one candidate.

(3) The Board of Supervisors will appoint a candidate at its December 13, 2011 meeting.

DISCUSSION:

In accordance with the above process, the Westborough Water District advertised the vacancy on its Board of Directors and received applications from the following three candidates:

- 1. **David John Irwin:** Mr. Irwin is an Electric Distribution Supervisor (Journeyman Lineman) at Pacific Gas & Electric. He co-founded, coaches, and serves on the Board of Directors of San Francisco Warriors Youth Football and Cheer. Mr. Irwin has a technical diploma in network engineering and management from Heald College. He lives in South San Francisco.
- 2. **Judith Gail Louie**: Ms. Louie is a purchasing assistant at UCSF. She has also worked as an underwriter for insurance companies. She attended City College of San Francisco. She is an active member of the Pacifica Beach Coalition and has been on the PG&E EarthDay Cleanup Board of Directors for 17 years. Ms. Louie lives in South San Francisco.
- 3. **Ronald C. Burgess**: Mr. Burgess has served most recently as an Account Executive for the insurance industry in California. He has also held various management positions at several insurance companies. Mr. Burgess has served as an adjunct professor at Golden Gate University and he has served on several boards and commissions, including the South San Francisco Housing Authority, the San Mateo County Transportation Authority Citizens Advisory Committee, and the Budget Finance Committee at the South San Francisco Unified School District. Mr. Burgess lives in South San Francisco.

Attached to this Memorandum are copies of the applications submitted by the three candidates listed above. The District Board interviewed each of the three candidates. After careful consideration, the District Board recommends that applicant David John Irwin be appointed to fill the vacancy on the Westborough Water District's Board of Directors.

Appointing David John Irwin as a member of the Board of Directors of the Westborough Water District will contribute to the Shared Vision 2025 outcome of collaborative community by engaging community participation in the appointment process.


